Mary Lundell made a motion to approve the December 10<sup>th</sup> minutes noting updates from the November minutes. Jeff Davis seconded the motion. The motion passed 3/0; Cheryle Peters declined to vote in light of her absence from the December and November meetings.

# **Zoning Requests:**

1. Mr. Dalton Leritz, 32880 Stanton Trail, requested a recommendation for approval to construct a 2880 square foot post frame building on Parcel # 410261000, 10 acres in the Township A-2. Goodhue County also zones the property A-2.

The site plan was reviewed; dimensions were stated as 45X64 with 16 tall walls and a 4/12 degree roof pitch. Mr. Leritz indicated that he planned to commence construction, pending the seasonal thaw. Jeff Davis made a motion to recommend, to the Town Board, approval for Mr. Leritz's request as it had been described. Mary Lundell seconded the motion. The motion passed 4/0. Mr. Leritz was advised to attend the Town Board meeting January 21<sup>st</sup>, for a review.

Per Continued Discussion regarding December's PC meeting"interim use permit" (IUP) content:

- 1. Continuance of "interim use permit" (IUP) discussion
  - a. Article 4 of Goodhue County Zoning Ordinances, section 2: We will use the County language to replace our B3 subdivision.
  - b. Article 4 of Goodhue County Zoning Ordinances, section 3, subdivision 5: reformat to match our ordinance formatting. Insert into our B to combine. When it refers to wetlands say "wetlands are referred to and regulated by Goodhue County". Subdivision 8; Leave the top language and takeout the list. Incorporate everything remaining.
  - c. Article 4 of Goodhue County Zoning Ordinances, section 4: This is similar to our subdivision B2. We would edit our current B2 to insert IUP.
  - d. Article 4 of Goodhue County Zoning Ordinances, section 5: We would use our ordinance B2c.

- e. Article 4 of Goodhue County Zoning Ordinances, section 6 & 7: We would use our subdivision B2d. We will add "to ensure its conditions have been maintained".
- f. Article 4 of Goodhue County Zoning Ordinances, section 8 & 9: We will use our F subdivision and add IUP to it.
- g. Article 4 of Goodhue County Zoning Ordinances, section 10: This is our H9 subdivision.
- h. All of section 15 from our ordinances will need to be updated to add IUP to every instance of Conditional Use Permit (CUP).
- 2. In summary, a clean copy working reference is planned to be available for continued review in February.
